Terms of Use

1. The Archives of Contemporary Arts' Terms of Use are an integral part of the application for access. By signing the application, the user enters into a contract with the Archives of Contemporary Arts. The user is responsible for complying with the Terms of Use and is liable for any and any damage or disadvantage to the Archives of Contemporary Arts resulting from non-compliance.
2. The collections of the Archives of Contemporary Arts may be used for any legitimate reason such as for scientific, literary, or journalistic purposes.
3. Users are kindly requested to inform the archive in advance of their arrival, the expected duration of their stay, and their intended use.
4. The user must sign an application for accessing the archival material. Persons unknown to the archive must present an official photo ID.
5. Requested materials can only be provided in limited quantities. Certain collections or specific items may be restricted or unavailable for conservation, legal, or other reasons.
6. All archival materials must be used in the reading rooms.
7. Coats, jackets, backpacks, folders, etc., may not be taken into the reading rooms. The archive assumes no liability for any personal belongings brought into the premises. Eating, drinking, smoking, and the use of mobile phones are prohibited.
8. Upon receipt of archival material users are advised to check immediately for completeness and any damage. If no complaint is made, the materials are deemed to have been received in perfect condition.
9. All items must be handled carefully and returned in their original order. When using manuscripts, only pencils and/or laptops may be used. Writing in or on the objects is prohibited. Materials must lie flat and unencumbered. The use of technical devices (cameras, scanners, voice recorders, etc.) requires separate authorization.
10. Permission to consult archival materials does not include the right to publish them. Any publication (in whole or in part) requires authorization from the Archives of Contemporary Arts. A separate application for publication permission must be submitted.

11. For archival materials protected by copyright, the application for publication permission must include written consent from the rights holders (authors, heirs, or other legal owners). The user bears sole responsibility for compliance with all rights relevant to publication, particularly copyright and personality rights. The user is also solely responsible for ensuring that any personality or data protection rights of individuals (authors, relatives, mentioned or identifiable persons) and the legitimate interests of third parties are respected and is liable for any violations.

12. In every publication or use, the source must be cited in full as "Land Niederösterreich – Archiv der Zeitgenossen" or "State of Lower Austria – The Archives of Contemporary Arts". The user is obliged to provide a complimentary copy of all publications and any revised editions or subsequent uses in which materials from the Archive of Contemporary Arts were used, free of charge and without request. For electronic publications, the archive is entitled to receive a copy on a suitable data carrier.

13. Permission to transcribe, copy, or publish materials does not affect the archive's own right to use these materials in any form or to authorize third parties to do so.

14. Reproduction of archival materials is only possible to a limited extent. Complete copying of finished or extensive works, large series of letters, or entire correspondence groups is generally not permitted. This also applies to archival materials in digital form. Exceptions (e.g., for editions or exhibitions) will be decided on a case-by-case basis. Transfers of audio and film recordings require special arrangements and authorization.

15. Reproductions of archival materials, books, journals, etc., are made exclusively by archive staff for a fee. All reproductions are intended solely for personal, noncommercial use, may not be passed on to third parties, and may not be published on the internet.
