## **Terms of Use**

1. The Archives of Contemporary Arts Terms of Use are part of the Application for Use. Upon signing the Application for Use, the user enters into a contract with the Archives of Contemporary Arts. The user is responsible for following the Terms of Use and will be held accountable for any and all damages or disadvantages to the Archives of Contemporary Arts in the event of non-compliance.
2. The collections of the Archives of Contemporary Arts can be used for any legitimate reason, such as for scientific, literary, or journalistic purposes.
3. Users are kindly requested to provide information on the estimated duration of their visit and type of use in advance to the greatest degree possible.
4. Each user must fill out an Application for Use. Individuals not personally known to the Archives of Contemporary Arts must provide proof of identity.
5. Only a limited number of requested materials can be made available. Due to conservation, legal, and other grounds, certain types of records and specific items can only be used to a limited degree or not at all.
6. All records and items must be viewed in the reading room.
7. No coats, jackets, backpacks, book bags, folders, or similar objects may be taken into the user area. No liability is assumed for objects brought into any part of the user area. It is forbidden to eat, drink, smoke, and use mobile telephones in any part of the user area.
8. When borrowing a record or item, an immediate examination for completeness and/or possible damage is recommended. If no mention of incompleteness or damage is made, it will be assumed that the records are complete and in good condition.
9. Records must be used with care and appropriate handling. Records must be returned in the same order they were borrowed in. Notes may be taken using only pencils or a laptop. It is forbidden to write in or on any record. Records must be carefully placed directly on the table and no object may be placed beneath or on top of them. Special permission is required for the use of technical devices such as cameras, scanners, dictaphones, etc.
10. Permission to view the contents of the archives does not include permission to publish any part of them. Any publication, in whole or in part, requires the express

permission of the Archives of Contemporary Arts. An application must be made in order to obtain permission to publish.

11. For records under copyright protection, written permission from the copyright holder (author, creator, legal heir, or other legal owner) must be attached to the Application for Permission to Publish. The user is solely and fully responsible for ascertaining and respecting any rights related to the publication of records, in particular copyright protections. The user is solely and fully responsible for ascertaining and respecting any personal and data protection rights of individuals (authors, their relatives, or any mentioned or identifiable persons) as well as the rightful legal interests of any third parties.

12. Any publication or use must list the source as the Government of Lower Austria / The Archives of Contemporary Arts. The user is required to supply the Archives of Contemporary Arts with a sample copy of any publication upon release, and of any later revised editions, free of charge and without being asked. The Archives of Contemporary Arts must be provided with a digital copy of any electronic publications.

13. Permission to transcribe, copy, or publish a record does not diminish the Archives of Contemporary Arts' own rights to use said materials in any way or to permit their use by third parties.

14. Copying records is only permissible to a limited degree. Making full copies of final or extensive works, longer exchanges of letter, or entire groups of correspondence is generally not permissible. This also applies to records available in digital form. Exceptions, for example for edition projects or exhibitions, may be made in specific cases. The copying of audio and film recordings requires special agreements and permissions.

15. Copies of records, books, magazines, etc. can only be made by employees of the Archives of Contemporary Arts and require a fee. All copies are for personal use only, may not be passed on to third parties, and may not be published on the internet.
